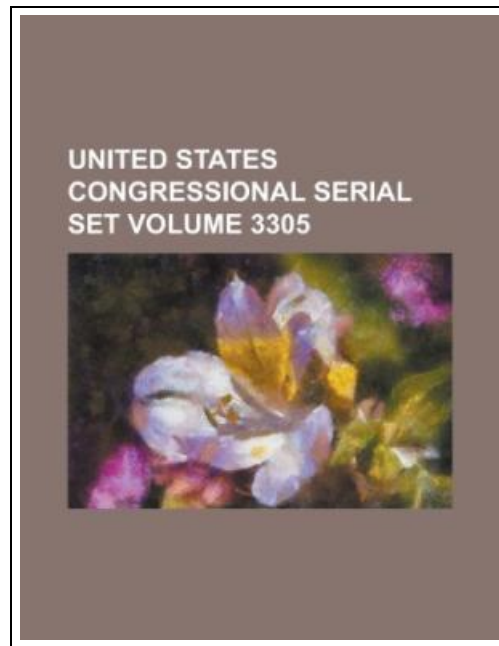

Furthermore, such organizations have effective safety management systems that include appropriate safety rules and procedures, employee adherence to these rules and procedures, well-defined processes for identifying and addressing safety-related problems, and adequate safety training available for employees and management.
