A detailed data-analysis plan is a key feature of an evaluation plan as it sets out who will do the analysis and when and how data will be analyzed to measure the pilot programs performance. IRS does not have a cost-effectiveness-analysis plan to help ensure that the program produces sufficient benefits in relation to its costs. For example, SB SE Research was asked to conduct an analysis with available phase I matched data using federal tax returns and Arkansas, Iowa, and Massachusetts state tax-amnesty data to determine SRFMIs cost effectiveness.
